

## Prize draw terms & conditions

Green Room 

1. The prize draw is open to all UK residents aged 16 years or over, except employees of Vision Critical (the “Administrator”) or AAT (the “Sponsor”), their families, agents or any third party directly associated with the administration of the prize draw.
2. To be eligible to enter the monthly prize draw, participants must complete at least one activity in the previous calendar month in AAT Green Room. Anyone who completes at least one activity in the previous calendar month in AAT Green Room will be automatically entered into the prize draw. Entry allocations will include one entry per study per period.
3. Neither the Administrator nor the Sponsor accept any responsibility for activities not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
4. A winner will be chosen by random draw once each calendar month on or about the last business day of that month. The Administrator will notify each selected entrant by email within fifteen business days of the draw date.
5. There will be a total of six winners each month who will each receive a cash prize of £50. Each winner may only receive a total of one £50 prize each calendar month.
6. In order to verify their identity, the Administrator will contact the winner by direct message via their AAT Green Room account with which they became eligible to enter the prize draw. The winner must respond within seven days of the Administrator’s notification message. Failure to respond within seven days to the Administrator will result in the initially selected winner waiving his/her right to the prize, another valid entry being selected from the remaining entries, and notification to a new winner, in the same manner detailed previously. This process will continue for up to two re-draws until a winner is determined. In the event that a winner is not determined after three total attempts the Administrator may elect not to conduct any further redraws and not award such prize(s).
7. The prizes will be paid in GBP by a third party via the secure pay out website Hyperwallet ([www.hyperwallet.com/why-hyperwallet](http://www.hyperwallet.com/why-hyperwallet)) acting on behalf of the Administrator.
8. The prize is supplied by AAT (The Association of Accounting Technicians) of 140 Aldersgate Street, London EWC1A 4HY (the "Sponsor").
9. The decision of the Administrator regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.
10. The winners’ names and county can be obtained by sending an email to [support@aatgreenroom.org](mailto:support@aatgreenroom.org) within 60 days of the draw date.
11. Participants are deemed to have accepted and agreed to be bound by these terms and conditions upon entry. The Administrator reserves the right to refuse entry, or refuse to award the prize to anyone in breach of these terms and conditions.
12. The Administrator reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

13. Insofar as is permitted by law, AAT, the Administrator, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Administrator, its agents or distributors or that of their employees. Your statutory rights are not affected.
14. The prize draw will be governed by English law and entrants to the prize draw submit to the jurisdiction of the English courts.
